Coin Design Contest: Askîy Challenge

The Métis Nation of Alberta (MNA) Environment and Climate Change department is holding an art contest to design a Métis-inspired challenge coin for MNA Citizens who participate in our Askîy environmental monitoring and conservation programs to recognize their contributions.

Contest Background


Challenge coins are small coins that organizations give away to represent membership, recognize service and excellence, or celebrate special events.

The Environment and Climate Change department conducts community-based monitoring programs through an initiative called Askîy (Cree for "Earth" or "land") to investigate and address Citizen environmental concerns. We have developed programs to monitor plants, fish, wildlife, and biodiversity using methods which braid western science with traditional knowledge. Monitoring programs are designed to engage with Citizens, facilitate knowledge sharing within the community, provide opportunities for community involvement in monitoring, and keep Citizens updated on project activities and outcomes.

The MNA is calling for artwork from MNA Citizens to create a suitable design for the Askîy challenge coin. MNA Citizens who participate will have the opportunity to win prizes.







Contest Criteria

- Artwork should be created using the Challenge Coin Design Template, found at: *albertametis.com/askiy-challenge-coin-contest*
- Artwork may be physical or computer generated.
- Artwork should illustrate the contest theme, "the connection of Métis people to the land (i.e., terrestrial plants and animals, landforms, rock, sand, soil, etc.)."

Evaluation

Each submission will be judged on:

- Practicality
- Interpretation
- Composition
- Creativity
- Presentation

How to Submit a Contest Entry

All contest submissions must include:

- An original artwork created using the Challenge Coin Design Template
- A completed Contest Entry Form
- A completed Participant Consent Form

The Contest submission deadline is midnight MDT on **December 31, 2022.**

No late entries will be accepted.

Eligibility

- The Askîy Challenge Coin Design Contest (the "Contest") is open to all individual MNA Citizens aged 18 years or older.
- Artwork must be unpublished and original.
- Artwork must be created by the participant.

Entry Information

Artwork must show the participant's interpretation of Métis people's connection to the land (i.e., terrestrial plants and animals, landforms, rock, sand, soil, etc.).

- Only one entry per participant. Group entries or multiple entries will not be accepted.
- Entries must be emailed or mailed by midnight (MDT) on **December 31, 2022.**
- Submissions must include a completed Contest Entry Form and Participant Consent Form.
- No copyright materials may be used for this Contest.
- Any false information provided within the context of the Contest by any participant concerning information provided in the Contest Entry Form, ownership or right or non-compliance with the rules or the like may result in immediate elimination from the Contest.
- The Rules may be changed without notice or reason including, if necessary, to comply with any applicable law. By entering the Contest, participants agree to these rules.
- This Contest shall be governed by and construed in accordance with these Rules, the laws of the Province of Alberta, and any applicable federal laws. These Rules govern all aspects of the Contest and are binding on all participants and other parties including a participant's parents or legal guardians, if applicable.


General Information

- Entries will be evaluated in the following categories:
 - ∞ Ages 18 to 59
 - ∞ Ages 60 and older
- Three contest winners will be selected from each category and awarded a prize:
 - ∞ 1st place: \$1,000
 - ∞ 2nd place: \$500
 - ∞ 3rd place: \$250
- One contest winner will be selected from all entries (both age categories combined) and awarded a grand prize:
 - ∞ iPad Pro (12.9-inch display, 1tb storage) + Apple Pencil – an approx. \$2,739 value
- The winner's design will be used to develop the MNA's challenge coin.
- The MNA may use the artwork or parts of the artwork for any advertisement, publication, promotion, or any other purposes.
- The MNA reserves the right to cancel, terminate, modify, or suspend the Contest for any reason, without any prior notice to any participant.
- Artwork submissions become the sole property of the MNA.
- Upon submission, all copyright in and to the artwork submission is transferred and assigned to the MNA.
- Participants grant the MNA the right to use, reproduce, reprint, distribute, perform, and/or display the participant's artwork without further compensation or notification of the participant.

Selection of Awards

- All entries will be reviewed and judged by members of the MNA's Askiy Advisory Committee
- Judges will evaluate each entry according to the following criteria:
 - Practicality how well the design transitions to a 1.75"/45 mm coin
 - Interpretation how well the design captures the contest theme
 - Composition how well the design considers framing and presentation (e.g., use of space)
 - ∞ Creativity how well the design demonstrates originality and innovation
 - $^{\circ\circ}$ Presentation how well the design appeals to and engages with a viewer
- Each participant who has submitted a winning entry will be notified by telephone or email that their entry has won and informed of the procedure to follow to claim the applicable prize. If the participant declines the prize, the prize may be forfeited and awarded to another.
- If the MNA does not receive entries of sufficient quantity or quality, the MNA reserves the right not to award any prizes.


