Askîy Youth Monitor Contest Guide



The Métis Nation of Alberta (MNA) Environment and Climate Change department is holding an essay-writing contest to find **four Métis youth aged 18-29** to participate in a week of fish monitoring activities led by MNA harvesters and staff from February 21-25, 2023.

To enter, youth must submit a 500-word essay explaining, "What would being part of the Askîy Youth Guardians Team and participating in Fish Health Monitoring mean to you? (i.e., connection to culture, learning a new skill, learning to feed yourself/family)". Interested youth should review the schedule on page 4 to ensure their availability before entering.

CONTEST BACKGROUND

The MNA Environment and Climate Change department conducts community-based monitoring programs through an initiative called Askîy (Cree for "Earth" or "land") to investigate and address Citizen environmental concerns. We have developed programs to monitor plants, fish, wildlife, and biodiversity using methods which braid western science with Traditional Knowledge. Monitoring programs are designed to engage with Citizens, facilitate knowledge sharing within the community, provide opportunities for community involvement in monitoring, and keep Citizens updated on project activities and outcomes.

In March 2021, we launched our Fish Health Monitoring Project, working with experienced harvesters to sample fish from select lakes across Alberta. Using both traditional gillnets and rod and reel techniques, harvested fish were measured and examined for fish health. All lethally-sampled fish were sent home with harvesters to later fillet, eat, and report back on internal fish health and palatability (e.g., taste, texture, smell). In 2022, we returned to many of the same lakes to sample again and collect fish for toxicology testing.

In mid-February 2023 we are continuing this work but are inviting Métis youth to participate and learn both traditional ice-fishing methods and fish health assessment techniques from our harvesters, as well as scientific monitoring techniques from MNA staff. Youth participants will form the Askîy Youth Guardians Team and learn and work together throughout the week to complete fish monitoring activities.

CONTEST CRITERIA

Essays must:

- Be typed and submitted in PDF format.
- Be one page and 500 words maximum.
- Answer the question: What would being part
 of the Askîy Youth Guardians Team and
 participating in Fish Health Monitoring mean
 to you? (i.e., connection to culture, learning a
 new skill, learning to feed yourself/family).

EVALUATION

Each submission will be judged according to the following criteria:

- Content
- Organization
- Creativity
- Presentation

HOW TO SUBMIT A CONTEST ENTRY

All contest submissions must include:

- An original essay submitted in PDF format and emailed to Environment@metis.org
- A completed Contest Entry Form
- A completed Participant Consent Form

Entries must be submitted by 11:59 p.m. MDT on December 31, 2022. Late entries will not be accepted.





MONITORING PLAN

MNA staff, harvesters, and the Askîy Youth Guardians Team will travel together for the week to complete monitoring activities on four lakes across Alberta. MNA harvesters will teach youth two ice-fishing methods and traditional ways to assess fish. MNA staff will provide instruction on western science-based fish monitoring methodologies.

We will depart from Edmonton on **February 21, 2023** and arrive back in Edmonton on **February 25, 2023**.

Youth residing outside of Edmonton will be reimbursed any costs for travel and accommodations required to participate in the monitoring activities.

Youth will have the opportunity to participate in:

- · Setting and pulling gillnets
- Rod-and-reel fishing
- Measuring fish

- · Examining fish for health indicators
- Evaluating ice thickness for safety
- Hear stories and learn from the harvesters

We will provide accommodations and a per diem for meals. All equipment necessary for monitoring will be supplied, but youth participants must bring their own outdoor clothing and footwear.

Youth will be expected to:

- Dress appropriately for the weather
- · Be on time
- Help the harvesters and MNA staff
- Conduct themselves safely and respectfully

The Askîy Youth Guardians Team will also share a camera to document their experiences throughout the week. The photos and videos will be made into a video and shared on our social media. Participants will also be welcome to post on their channels during the monitoring week, tagging us on Facebook @ABmetis or Instagram @albertametis using #AskiyGuardian and #MNAyouth.

MONITORING SCHEDULE

Exact meeting and departure times will be provided in a schedule to be shared with successful participants.

Morning: Meet in Edmonton Drive to Calling Lake and set nets Stay overnight in Athabasca

FEBRUARY 22

Morning: Pull nets from Calling Lake, assess fish Drive to Lesser Slave Lake and set net Stay overnight in Slave Lake

FEBRUARY 23

Morning: Pull nets from Slave Lake, assess fish Drive to Sturgeon Lake and set nets Stay overnight in Valleyview

FEBRUARY 24

Morning: Pull nets from Sturgeon Lake, assess fish Drive to Pigeon Lake and set nets Stay overnight in Pigeon Lake area

FEBRUARY 25

Pull nets from Pigeon Lake, assess fish Participate in the MNA's Children and Family Services Frosty Reels family camp Return to Edmonton



CONTEST RULES

ELIGIBILITY

- The Askîy Youth Monitor Contest (the "Contest") is open to all individual MNA Citizens aged 18-29.
- Essays must be unpublished and an original entry. No copyright materials may be used for this Contest.
- Essays must be created by the participant.

ENTRY INFORMATION

- Essays must be a maximum 500-word essay and answer the question: What would being part of the Askîy Youth Guardians Team and participating in Fish Health Monitoring mean to you? (i.e., connection to culture, learning a new skill, learning to feed yourself/family).
- Only one essay submission per participant.
 Multiple entries per Citizen or group entries will not be accepted.
- Entries must be emailed to Environment@metis.org by 11:59 p.m. (MDT) on December 31, 2022.
- All essay submissions must include a completed Contest Entry Form and Participant Consent Form to be considered a valid entry.
- Any false information provided within the context of the Contest by any participant concerning information provided in the Contest Entry Form, ownership or right or non-compliance with the rules or the like may result in immediate elimination of the individual from the Contest.
- The Rules may be changed without notice or reason including, if necessary, to comply with any applicable law. By entering the Contest, participants abide by these rules.
- This Contest shall be governed by and construed in accordance with these Rules, the laws of the Province of Alberta, and any applicable federal laws. These Rules govern all aspects of the Contest and are binding on all participants and other parties including a participant's parents or legal guardians, if applicable.

GENERAL INFORMATION

- Contest entries will be evaluated in a single category, with no preference given for age or gender.
- Four contest winners will be selected to participate in the MNA's Askîy fish health monitoring work in February 2023 as a part of the Youth Guardians Team.
- Essays or parts of essays may be used by the MNA for any advertisement, publication, promotion, or any other purposes.
- The MNA reserves the right to cancel, terminate, modify, or suspend the Contest for any reason, without any prior notice to any participant.
- Essay submissions become the sole property of the MNA.
- Upon submission, all copyright in and to the essay submission is transferred and assigned to the MNA.
- Participants grant the MNA the right to use, reproduce, reprint, distribute, perform, and/or display the participant's essay without further compensation or notification of the participant.

SELECTION OF AWARDS

- All entries will be reviewed and judged by the team of MNA harvesters who participate in the Askîy Fish Health Monitoring program.
- Judges will evaluate each entry according to the following criteria:
 - » Content how relevant the essay is to the theme question and the originality of the response.
 - » Organization how well the essay is organized and laid out. The main point is clear and highlighted and the essay uses clear and easy-to-understand language.
 - » Creativity how well the essay demonstrates personal expression and importance related to the contest question.
 - » Presentation the mechanics of the essay, including punctuation, spelling, and grammar.
- Each participant with a winning entry will be notified by telephone or email that they have been selected for the Youth Guardians Team. Arrangements will then be made for their participation and to organize travel details. If the participant declines the prize, the prize may be forfeited and awarded to another.
- If the MNA does not receive entries of sufficient quantity or quality, the MNA reserves the right not to select any participants for the monitoring work.
