Judicial Tribunal Member

Judicial Branch Act, s. 6, 13-14, 16-17; Constitution, ch. 17.1

The Judicial Tribunal is an impartial body of the Judicial Branch of the Otipemisiwak Métis Government containing 6 members, one from each of the 5 Territories, and a chairperson. Tribunal members must faithfully and impartially exercise their duties under the Constitution and Otipemisiwak Métis Government Law to the best of their judgement, skill, and abilities. Tribunal members are appointed by the Citizens' Council by ordinary resolution, after the first General Election 3 of the members will serve a 2 years term, and 3 (including the chairperson) will serve a 4 year term, and every appointment of members thereafter will serve for a 4 year term. The Judicial Tribunal has the authority to decide and prescribe the resolution of disputes regarding the following:

- a) Citizenship in the Métis Nation within Alberta;
- b) Election of leadership of the Otipemisiwak Métis Government;
- c) The interpretation and application of the Constitution;
- d) The validity, application, and interpretation of Otipemisiwak Métis Government Law, regulations, or policies;
- e) Actions, inactions, or decisions of the Otipemisiwak Métis Government or its Institutions; and
- f) Contraventions of the Constitution or Otipemisiwak Métis Government Law.

Applicants for a Judicial Tribunal member position must meet the following qualifications:

- 1. Be a Citizen of the Otipemisiwak Métis Government;
- 2. Be 25 years of age or Older;
- 3. Not have been convicted of an indictable offence under the Criminal Code for which they have not received a pardon or record suspension that has not been revoked or ceased to have effect:
- 4. Demonstrate fair-mindedness and wisdom in decision-making;
- 5. Not hold an elected position with the Otipemisiwak Métis Government; and
- 6. Members other than the chairperson are appointed from each Territory and must be ordinarily resident in that Territory.
