Failure to complete all the required sections of this form will result in your application being returned to you.

Entitlement to a Métis Nation of Alberta Membership

“Métis” – a person who self identifies as Métis, is distinct from other Aboriginal peoples, is of historic Métis Nation ancestry and is accepted by the Métis Nation.

A Métis must provide historical proof of his or her status as Métis:

- a) Historic Proof – evidence of an ancestor who received a land grant, or a scrip grant under the Manitoba Act or the Dominion Lands Act, or who was recognized as a Métis in other government, church or community records;
- b) Historic Métis Nation means the Aboriginal people then known as Métis or Half-Breeds who resided in historic Métis Nation Homeland;
- c) Historic Métis Nation Homeland means the area of land in west central North America used and occupied as the traditional territory of the Métis or Half-Breeds as they were then known.

Métis Homeland: the Homeland, geographically, embraces all three prairie provinces (Manitoba, Saskatchewan and Alberta) also parts of Ontario, Northwest Territories and British Columbia

Requirements Checklist

- ∞ A completed genealogy (family tree) which clearly outlines your Métis ancestry to the mid 1800's.
- ∞ Copy of **ONE** of the following:
 - o Live Birth Registration
 - o Long Form Birth Certificate showing the full names of biological parents
 - o Wallet-size birth certificate **PLUS** copy of baptismal certificate with church seal (legible) and officiates signature
- ∞ One (1) piece of current photo identification
- ∞ Proof of permanent residency in Alberta for a minimum of ninety (90) consecutive days may be required.

Replacement Card

If you require a replacement card, please contact the Provincial Office. There is a \$40.00 replacement fee should you have yours lost/stolen. We accept cash or money orders **ONLY**, payable to: *Métis Nation of Alberta*. **It is the responsibility of the applicant to keep our office updated if you should move or your contact information changes.**

Family Tree Information

All applications **REQUIRE** a family tree starting in their name. If you are going to reference a family members' family tree already on file, you need to be able to show your link to them and your own tree needs to go back to at least your grandparents. You need to state the family member's full name, date of birth and their Métis ID number (if applicable).

Photo Specifications

The Membership process will be delayed if the following guidelines are not followed:

IMAGE INFORMATION:

- Photos must be taken with uniform lighting and not show shadows or flash reflection on the face and head
- Photos must show a full front view of the face with both edges of the face showing clearly. The face and shoulders must be centered in the photo and squared to the camera
- Eyes must be open and clearly visible. Glasses, included tinted ones with prescription, may be worn as long as the eyes are clearly visible. Sunglasses are unacceptable
- The image must be clear, sharp and in focus
- Photos must be taken against a plain, uniform, white or light colored background
- Photos must reflect/represent natural skin tones
- Hats or head coverings are not permitted except when worn for religious reasons and only if the full facial features are clearly visible
- Photos must be in color

ADDENDUM MEMO TO ‘APPLICATION FOR MÉTIS NATION OF ALBERTA MEMBERSHIP’ REGARDING OATH OF MEMBERSHIP

All individuals applying for MNA membership after May 30, 2017 should read this memo.

One MNA member, in his individual capacity, has challenged the MNA’s Oath of Membership (“Oath”) in the Alberta courts. Until this legal challenge has been resolved, the MNA has voluntarily consented, as set out in a court order, to not enforce the duly passed requirements of the MNA Bylaws that require all new applicants to sign the Oath as a part of their application for membership (MNA Bylaws, Article 10.9). Until further notice, all membership applications received after May 30, 2017 will continue to be processed and approved by the MNA (if all other membership requirements are met) with or without a signed Oath. In effect, these new applicants have two options: (1) they can sign the Oath, or, (2) they don't sign the Oath.

With that said, all new applicants who decide to not sign the Oath should be aware that if this individual’s legal challenge to the Oath is ultimately unsuccessful, their previously approved MNA membership would be subject to cancellation unless they promptly sign the Oath at that time. This is because they would not be in compliance with Article 10.9 of the MNA Bylaws, which states that “the oath of membership shall be a requirement for all future individuals to sign as a part of their application for membership in the Métis Nation of Alberta.” In addition, any individual’s membership application that is still being processed at the time of such a court determination would be delayed and not approved until such time as the MNA had received a signed Oath from the applicant.

Based on the above, the MNA is encouraging all new applicants to sign the Oath as a part of their membership application because the MNA is confident that the Oath will ultimately be upheld by the courts. Signing the Oath will ensure that members who apply for or are approved for membership during this period will not have their memberships cancelled or the approval of their applications delayed in the future when the Oath and Article 10.9 of the MNA Bylaws are upheld. However, while the MNA is encouraging all new applicants to complete the Oath (as over 2,000 new applicants have already done), new applicants have the option as to whether they sign the Oath or not until further notice.

For convenience, the relevant wording of the court order discussed above reads as follows: “any requirement by MNA of any person applying for membership as of September 14, 2016, who had not, as of the date of this Order, signed the oath of membership, to sign the oath of membership, shall not be enforced by MNA pending the earlier of October 20, 2017 (unless extended by the parties by consent or order of the Court) or the final determination of the matter, due to the legality of the oath of membership being under review by a court of law, to be determined on October 18-20, 2017, but may be enforced thereafter by the MNA if the bylaw is upheld.”
