Included in the package are some guidelines to help ensure proper procedures are followed according to the Métis Nation of Alberta Association Election By-Laws.

**All forms must bear original signatures; faxed or photocopied signatures will not be accepted.**

Candidates to provide the Chief Electoral Officer with the following:

1. The required number of signatures of electors and candidate's signature (attached form).
2. Completed and signed Statutory Declaration (attached).
3. An original letter from Indigenous and Northern Affairs Canada must be dated between opening of nominations June 22, 2018 to the close of nominations July 25, 2018 (attached sample). The letter shall be addressed to you declaring that you are not currently registered as a status Indian under the provisions of the *Indian Act*. Application for the letter may be made to Mr. Stephen Nichols Head, Indian Registration and Band Lists, Telephone: 780-495-4162 Indigenous and Northern Affairs Canada - Alberta Region Suite 630 Canada Place, 9700 Jasper Avenue. Candidates must provide Indigenous and Northern Affairs Canada with: a birth certificate and valid government issued photo I.D. To ensure that the letter is processed in time, it is recommended that candidates apply as early as possible.
4. A non-refundable deposit of two hundred dollars (\$200.00) that shall be deposited into the Education Foundation of the Métis Nation of Alberta Association. Candidates are requested to provide cash, a certified cheque, or money order payable to Métis Nation of Alberta.
5. Qualified candidates must complete all documents and all **Original Nomination Papers** must be filed with the Chief Electoral Office (photocopies and facsimile copies will not be accepted).
6. Candidates must provide the Chief Electoral Office with a valid government issued photo identification card (i.e. driver's license) to verify residency requirement.

Upon receipt and verification of nomination papers, all candidates will be notified by the Chief Electoral Officer.

Finally, while there are a specified number of signatures from Métis Nation of Alberta Association members required for nomination, it is strongly recommended that all candidates obtain extra signatures.

Should the need arise, the office of the Chief Electoral Officer may provide more packages to the Regions and/or candidates. The package may also be printed from the website [www.albertametis.com](http://www.albertametis.com).

In accordance with ARTICLE 3.1 of the Election By-Laws, notice is hereby given that the **GENERAL ELECTION** of all Elected Officers of the Métis Nation of Alberta will be held on **Tuesday, September 18, 2018**.

Elected Officers include President, Vice-President, six (6) Regional Presidents, and six (6) Regional Vice-Presidents.

Voting will be by secret ballot in the elector's polling subdivision. Polling Station locations will be posted in the Chief Electoral Office, Regional Offices, the Provincial Office, and [www.albertametis.com](http://www.albertametis.com).

**Election Day – September 18<sup>th</sup> 8:00 a.m. - 8:00 pm**

To be an eligible elector, each member must be properly registered with the Métis Nation of Alberta.

  - (i) names of the candidates; and

### Métis Nation of Alberta Election By-Laws:

#### ARTICLE 6 NOMINATION OF CANDIDATE

**6.4:** A Métis Lifetime member is eligible to be nominated as a candidate in an election if on the day his or her nomination paper is filed he or she:

- (a) is a Métis Lifetime member who is entitled to hold office; and
- (b) is of the full age of sixteen (16) years or will be that age on election day; and
- (c) has been ordinarily a resident of Alberta continuously from the day 12 months immediately preceding the election day; and
- (d) has no financial debt owing to the Métis Nation or its affiliates that is more than thirty (30) days in arrears;

**6.5:** All nominations for President and Vice-President shall include the following:

- (a) written acceptance of the nomination by the candidate; and
- (b) one hundred and fifty (150) signatures of electors nominating the candidate; and
- (c) a non-refundable deposit in the sum of Two Hundred Dollars (\$200.00).
- (d) a deposit that is not refundable under this section shall be deposited in the general account of the Métis Education Foundation.
- (e) persons applying to hold an elected office within the Métis Nation of Alberta shall provide an official letter to the Chief Electoral Officer declaring that they are not currently registered with the Department of Indian Affairs as a status Indian under the provisions of the *Indian Act*.

**6.6:** All nominations for the Regional President and Regional Vice-President shall include the following:

- (a) written acceptance of the nomination by the candidate; and
- (b) seventy-five (75) signatures of electors who reside in the Region nominating the candidate; and
- (c) a non-refundable deposit in the sum of Two Hundred Dollars (\$200.00).
- (d) A deposit that is not refundable under this section shall be deposited equally in the general account of the foundations of the Regional Council of the candidate;
- (e) Persons applying to hold an elected office within the Métis Nation of Alberta shall provide an official letter to the Chief Electoral Officer declaring that they are not currently registered with the Department of Indian Affairs as a status Indian under the provisions of the *Indian Act*.

The election will adhere to all provisions contained within the By-laws of the Métis Nation of Alberta and the Alberta Elections Act.

## Province of Alberta Election Act 135(1)

### **No election advertising at polling place**

- (1) Subject to subsection (2), no person may
- (a) display inside or on the outside of, or
  - (b) distribute within,

a building used for a polling place at an advance poll or on polling day, or within the boundaries of the land on which the building is located, any election circular, card, poster, bill or other paper except those posted by the deputy returning officer or other election officials as required by this Act.

(2) When a polling place is located in a building containing a complex of interlocking offices, stores or other facilities, the prohibition in subsection (1) applies only to the store, office, or facility comprising the area designated as a polling place.

(3) Where a person displays any circular, card, poster, bill, or other paper contrary to subsection (1) or (2), the returning officer may cause it to be removed, and neither the returning officer nor any person acting under the returning officer's instructions is liable for trespass or damages resulting from or occasioned by the removal.
