WHEREAS the Otipemisiwak Métis Government, through its legal and administrative arm the Métis Nation of Alberta Association, controls a number of important affiliated entities ("Otipemisiwak Métis Government Institutions"), including but not limited to: (i) Métis Crossing; (ii) Rupertsland institute; and (iii) Métis Urban Housing Corporation;

**AND WHEREAS** pursuant to the Otipemisiwak Métis Government's *Transition Plan*, Otipemisiwak Métis Government Institutions shall remain controlled by the OMG, continue to exist in their current form, and continue to deliver programs and services to Citizens of the OMG:

**AND WHEREAS** through inadvertence or otherwise, corporate records for certain Otipemisiwak Métis Government Institutions are inaccurate and/or outdated with respect to the registered directors and officers of such Otipemisiwak Métis Government Institutions;

**AND WHEREAS** in certain instances, further amendments to the bylaws or other constating documents of Otipemisiwak Métis Government Institutions may be required in order to align Otipemisiwak Métis Government Institutions with the Otipemisiwak Métis Government Constitution and Otipemisiwak Métis Government laws and regulations.

#### THEREFORE BE IT RESOLVED THAT:

- 1) The President and Senior Executive Officer of the Otipemisiwak Métis Government are authorized and empowered to direct legal counsel to update the corporate records and amend the bylaws or other constating documents of Otipemisiwak Métis Government Institutions to bring the corporate records in alignment with the Otipemisiwak Métis Government Constitution and Otipemisiwak Métis Government laws and regulations.
- 2) The President and Senior Executive Officer are authorized and empowered to direct legal counsel to take all such further action and to execute and deliver all such further agreements, certificates, instruments, and documents, in the name and on behalf of the Otipemisiwak Métis Government and the Métis Nation of Alberta Association, to carry out the transactions contemplated by and the intent and purposes of the foregoing resolution.
