5. The results of the District Elections are set out in the Announcement of Certified Results attached as Exhibit “B” to this Declaration.
6. The results of the District Elections in Exhibit “B” include the final results of recounts in the following races, which were conducted under the authority of the Chief Electoral Officer as set out at Section 105 of the Act and in accordance with the procedures for recounts as prescribed by the Act:
 - a) a complete recount in the race for District Captain in Fort Edmonton Métis District No. 9 conducted on November 12, 2024,
 - b) a complete recount in the race for District Councillor in Athabasca Landing Métis District No. 20 conducted on November 13, 2024.


