WHEREAS for generations, Métis Nation citizens in Alberta and the Métis communities comprised of those citizens (collectively, the "Métis Nation within Alberta"), have exercised their inherent rights of self-government and self-determination, including through establishing the Métis Nation of Alberta ("MNA") as a distinct Métis government to represent them for the purposes of self-government and advancing their collective Métis rights;

**AND WHEREAS** historically the federal and provincial governments have refused to recognize the self-government and self-determination rights of the Métis Nation within Alberta and required the MNA to incorporate under Alberta's Societies Act in order to facilitate funding arrangements and intergovernmental relations through an entity that had legal status and capacity as recognized in Canadian law;

**AND WHEREAS** the Métis Nation within Alberta has long sought to have its self-government recognized through a modern-day treaty or other constitutionally-protected agreement or arrangement with the Crown and has, since 2017, been in negotiations with the federal government to reach such a treaty, including implementation legislation, that once concluded and in effect will mean the MNA no longer needs to rely on Alberta's *Societies Act*;

**AND WHEREAS** in September 2023, the Otipemisiwak Métis Government Constitution came into force, which established the Otipemisiwak Métis Government as the successor to the MNA, and includes the recognition that for the purposes of good governance and the effective representation of Métis Nation within Alberta Citizens, the Territories of the Métis Nation within Alberta would be subdivided into Districts and that each District would have a District Council which will be a governance structure of the Otipemisiwak Métis Government and have its own legal status and capacity under the treaty and implementation legislation;

AND WHEREAS also in September 2023, the Otipemisiwak Métis Government's District



Councils Act (the "District Councils Act") came into force, section 10 of which provides that:

To establish a District Council:

- (a) the Citizens of the District must elect a District Captain;
- (b) the District Captain must adopt Bylaws in accordance with section 12 of this Act; and
- (c) the Citizens' Council must approve the District Council Bylaws by resolution,

whose approval must not be withheld unless the Bylaws do not conform to the Constitution or Otipemisiwak Métis Government Law;

**AND WHEREAS** on November 20, 2023, the Otipemisiwak Metis Government Citizens' Council directed that self-government staff continue engagements with the MNA's Local and Regional Councils as well as newly elected District Captains with a view to establishing District Councils in every District of the Métis Nation within Alberta;

**AND WHEREAS** further to that engagement, the proposed District Council Bylaws for the Districts of Fort Edmonton Métis District, Jasper House Métis District, and Lac La Biche Métis District (attached hereto as Annex "A") have been reviewed and conform to the Otipemisiwak Métis Government Constitution and Otipemisiwak Métis Government Law;

**AND WHEREAS** further to that engagement, the District Council Bylaws for the Foothills Métis District (attached hereto as Annex "B") were approved-in-principle by the Citizens' Council of the Otipemisiwak Métis Government on November 7, 2024;

AND WHEREAS as a transitionary step while the federal government and the Otipemisiwak Métis Government continue negotiations to reach the treaty, the Otipemisiwak Métis Government and its District Councils will continue to rely on incorporated bodies under Alberta's Societies Act to provide them with legal status and capacity and to implement and give effect to the Otipemisiwak Métis Government Constitution;

**AND WHEREAS** the District Captains of Foothills Métis District, Fort Edmonton Métis District, Jasper House Métis District, and Lac La Biche Métis District (collectively, the "**Incorporating District Councils**") will incorporate new bodies under Alberta's Societies Act to serve as the District Councils of those Districts;

**AND WHEREAS** to facilitate the effective and efficient incorporation of the District Councils under Alberta's Societies Act and ensure that it is done in a manner that aligns with the Métis Nation within Alberta's overall self-government implementation and transition work, the Otipemisiwak Métis Government wishes to work together with the District Captains (and other incorporators for each District Council) of the Incorporating District Councils throughout the incorporation process, including by having a joint retainer for legal counsel with respect to the incorporation process;



## THEREFORE BE IT RESOLVED THAT:

#### Approval-in-Principle of Bylaws

1) Subject to technical and legal edits as may be required, the District Council Bylaws for the Districts of Fort Edmonton Métis District, Jasper House Métis District, and Lac La Biche Métis District are approved in principle.

#### Final Approval of Bylaws

2) The District Council Bylaws for the Foothills District Council are approved in accordance with section 10 of the District Councils Act.

#### General

- The President and Senior Executive Officer of the Otipemisiwak Métis Government are authorized and empowered to enter into limited-scope joint retainer agreements with the District Captains and other incorporators for each Incorporating District Council, for the purposes of having joint legal representation with respect to the incorporation of each of the Incorporating District Councils.
- 4) The President and Senior Executive Officer of the Otipemisiwak Métis Government are authorized and empowered to take all such further action and to execute and deliver all such further agreements, certificates, instruments, and documents, in the name and on behalf of the Otipemisiwak Métis Government and the Métis Nation of Alberta Association, to carry out the transactions contemplated by the intent and purposes of the foregoing resolutions.

### 2:10PM RESOLUTION (by MOTION) #20241218-8: Moved by: Sec. Brooke Bramfield

**WHEREAS** beginning in the 1950s and continuing until the 1990s, welfare agencies throughout Canada removed First Nations, Inuit, and Métis children from their parents, families, and communities and placed them with non-Indigenous foster or adoptive parents in a systemic practice known as the "Sixties Scoop";



**AND WHEREAS** the Sixties Scoop wrought enormous destruction upon First Nations, Inuit, and Métis communities-families were broken, children were disconnected from their cultures, and languages were lost. It is commonly accepted that these harms inflicted upon Indigenous individuals and collectives amounted to cultural genocide;

**AND WEREAS** on June 21, 2018, the Crown reached a settlement agreement that resolved numerous class actions relating to the Sixties Scoop and resulted in compensation to all First Nations and Inuit victims of the Sixties Scoop between 1951 and 1991. The settlement agreement excluded Métis and non-status Indian victims of the Sixties Scoop;

**AND WHEREAS** on December 20, 2018, a class action was filed in the Federal Court seeking relief on behalf of individual Métis and non-status Indian victims of the Sixties Scoop that were excluded from the 2018 settlement agreement ("**Varley Action**"), and the Otipemisiwak Métis Government ("**OMG**") was granted leave to intervene in a summary judgment motion in the Varley Action heard December 9 to 12, 2024;

**AND WEREAS** in addition to the harms inflicted upon individual victims, the Sixties Scoop also caused permanent harm to the Métis Nation within Alberta as a collective-whose survival is dependent on its ability to pass traditions, language, culture, and identity on to future generations-by operationalizing cultural genocide and threatening to erase the Métis as one of the constitutionally recognized Aboriginal peoples of Canada;

**AND WHEREAS** the OMG is committed to holding the Crown accountable for all harms it has caused in relation to its abuses and negligence toward Métis children in care, their parents, their families, and their Métis communities, and-more generally-improving child and family services for the Métis Nation within Alberta on a culturally appropriate and respectful basis;

## THEREFORE BE IT RESOLVED THAT:

- 1) Aird & Berlis LLP are directed to prepare and file an action on behalf of the OMG to hold the Crown accountable for the harms the Sixties Scoop caused the Métis Nation within Alberta-as a Métis collective ("**OMG Sixties Scoop Action**").
- 2) Administration is directed to develop and implement a communications strategy to ensure Citizens are informed about the Otipemisiwak Métis Government Sixties Scoop Action on an ongoing basis.

**Result:** Consensus failed

*ss.59(1) Question of Order | President Andrea Sandmaier:* Pursuant to ss. 75(c) of the *Self-Government Act*, and upon review and consideration of the debate from the floor, President Sandmaier declared that consensus could not be reached on the motion and directed the Chair to call for a vote pursuant to Council procedure as established by ss. 47(1) of the *Self-Government Act*.

*ss.59(2)* Question of Order | Sec. Rebecca Lavallee: Requested that a vote, if required, be recorded, with the outcome of each Council representative's vote attributed to their name in the record of proceedings.

*ss.59(2) Question of Order | Sec. Karen Collins:* Requested that a vote, if required, be undertaken by secret ballot, with only the aggregated result recorded in the record of proceedings.

*ss.59(2) Question of Order | Rep. Lisa San Filippo:* Called for a friendly amendment to the motion to be considered by the Mover and Seconder.

- 2:28PM The Chair declared the proceedings of Council to stand in recess, to consider four Questions of Order.
- 3:00PM The Chair recalled the proceedings of Council to order and reported back the following decisions of the Chair in respect to four Questions of Order:
  - 1) Does consensus exist, is a majority vote required?

The President having concluded that consensus is not able to be reached which is within her authority pursuant to ss. 75(c) of the *Self-Government Act*. The President directed the Chair to call for vote. In accordance with ss. 59(1), the Chair may make decisions on Questions of Order, practice and procedure of the Citizens' Council. Accordingly, the decision of the Chair is as follows: when the Chair called for consensus on the motion pursuant to ss. 47(1) of the *Self-Government Act*, consensus was declared failed. Given that consensus was not achieved, and the President confirmed their position that consensus would not be achieved through further debate, ss. 47(1) is clear and prescribes that "Citizens'



Council must make decisions by a majority vote." There is no period of delay prescribed in the legislation between the failure of consensus as confirmed by the President, and the requirement for a vote of the majority to begin. Accordingly, the Chair determined that the Question of Order is in order, that voting on the motion begun when the test for consensus was first formally called by the Chair, and that a majority vote of the Council Representatives present is required to be undertaking, with the results recorded.

2) Request by Sec. Rebecca Lavallee that the vote be recorded, with the outcome of each Council Representative's vote attributed to their name in the record of proceedings.

Section 45a) of the *Self-Government Act* requires that "the results of the vote taken, to be recorded". The Chair determined the *Self-Government Act* to be silent on whether the result requires representatives to be identified with the outcome of their vote. Accordingly, pursuant to the authority of the Chair prescribed by ss. 59(2), the Chair decides as follows: The request contained within the Question of Order, constitutes a deviation from established practice of Citizens' Council. In the opinion of the Chair, "recording" of "results of the vote taken" requires only that the number of votes in favor, the number of votes opposed, and the number of abstentions be recorded. The Question of Order and associated request is deemed out of order.

3) Request by Sec. Karen Collins for a vote by secret ballot.

The Chair determined the *Self-Government Act* to be silent in respect to votes of Citizens' Council to be undertaken by secret ballot, pursuant to the authority of the Chair prescribed by ss. 59(2), the Chair decides as follows: the question of secret ballot voting must be informed by the established practices of Council and s. 16 of the *Self-Government Act*, which refers to voting at the Citizens' Gathering, which requires voting to be undertaken by show of hands. To date, all decisions of and Cabinet have been made either by consensus of by show of hands. Voting by secret ballot would be a significant deviation from established practices of Citizens' Council and the Question of Order and associated request is deemed out of order.

4) Request for a friendly amendment to the Motion by Rep. Lisa San Filippo.

The Chair determined that the *Self-Government Act* is silent in respect to the timing and permissibility of friendly amendments to a Motion tabled before the Citizens' Council. Pursuant to the authority of the Chair prescribed by ss. 59(2), the Chair decides as follows: established practice of the Citizens' Council, as well as nearly all other systems of parliamentary procedure, prescribe that a motion



may not be amended once voting has begun. Pursuant to the interpretation of ss. 47(1), voting began when the Chair first formally called for consensus on the motion. Accordingly, the Question of Order and associated friendly amendment is deemed out of order.
