 - (a) Execute and deliver the Documents with such changes, if any, as the authorized signatories may deem necessary or advisable, such execution to be conclusive evidence of their approval of any such changes;
 - (b) Execute and deliver all such instruments, agreements and other documents and take such further and other action as in such the President and Senior Executive Officer's opinion may be necessary or desirable, now or in the future, to facilitate or complete the transactions and agreements hereby approved and authorized; and
 - (c) Execute and deliver any replacements, extensions, amendments, renewals, or supplements to any of the foregoing as he or she may deem necessary or advisable at any time or from time to time.
