**WHEREAS** for generations, Métis Nation citizens in Alberta and the Métis communities comprised of those citizens (collectively, the "**Métis Nation within Alberta**"), have exercised their inherent rights of self-government and self-determination, including through establishing



the Métis Nation of Alberta ("**MNA**") as a distinct Métis government to represent them for the purposes of self-government and advancing their collective Métis rights;

**AND WHEREAS** historically the federal and provincial governments have refused to recognize the self-government and self-determination rights of the Métis Nation within Alberta and required the MNA to incorporate under Alberta's *Societies Act* in order to facilitate funding arrangements and intergovernmental relations through an entity that had legal status and capacity as recognized in Canadian law;

**AND WHEREAS** the Métis Nation within Alberta has long sought to have its self-government recognized through a modern-day treaty or other constitutionally-protected agreement or arrangement with the Crown and has, since 2017, been in negotiations with the federal government to reach such a treaty, including implementation legislation, that once concluded and in effect will mean the MNA no longer needs to rely on Alberta's *Societies Act*;

**AND WHEREAS** in September 2023, the Otipemisiwak Métis Government Constitution came into force, which established the Otipemisiwak Métis Government as the successor to the MNA, and includes the recognition that for the purposes of good governance and the effective representation of Métis Nation within Alberta Citizens, the Territories of the Métis Nation within Alberta would be subdivided into Districts and that each District would have a District Council which will be a governance structure of the Otipemisiwak Métis Government and have its own legal status and capacity under the treaty and implementation legislation;

**AND WHEREAS** also in September 2023, the Otipemisiwak Métis Government's *District Councils Act* (the "*District Councils Act*") came into force, section 10 of which provides that:

To establish a District Council:

- (a) the Citizens of the District must elect a District Captain;
- (b) the District Captain must adopt Bylaws in accordance with section 12 of this Act; and
- (c) the Citizens' Council must approve the District Council Bylaws by resolution, whose approval must not be withheld unless the Bylaws do not conform to the Constitution or Otipemisiwak Métis Government Law;

**AND WHEREAS** on November 20, 2023, the Otipemisiwak Métis Government Citizens' Council directed that self-government staff continue engagements with the MNA's Local Councils ("**Local Councils**") and Regional Councils as well as newly elected District Captains with a view to establishing District Councils in every District of the Métis Nation within Alberta.

**AND WHEREAS** further to that engagement, the District Council Bylaws for the Fort McMurray Métis District (the "**Fort McMurray District Council Bylaws**", attached hereto as Annex "A") were approved-in-principle by the Citizens' Council of the Otipemisiwak Métis Government on January 29, 2025;

**AND WHEREAS** the members of Metis Nation of Alberta Association Fort McMurray Local Council 1935 (the "Fort McMurray Local") passed a special resolution on April 28, 2025,



authorizing the Fort McMurray Local's transition to the District Council of the Fort McMurray Métis District and adopting the Fort McMurray Bylaws;

**AND WHEREAS** as a transitionary step while the federal government and the MNA continue negotiations to reach the treaty, the Otipemisiwak Métis Government will transition the Local Councils already existing under Alberta's Societies Act into District Councils to provide them with legal status and capacity and to implement and give effect to the Otipemisiwak Métis Government Constitution;

**AND WHEREAS** to facilitate the effective and efficient transition of the Fort McMurray Local to the District Council of the Fort McMurray Métis District and ensure that it is done in a manner that aligns with the Métis Nation within Alberta's overall self-government implementation and transition work, the Otipemisiwak Métis Government will work with the Fort McMurray Local and their legal counsel to take all corporate steps required to effect the transition;

#### THEREFORE BE IT RESOLVED THAT:

#### Approval-in-Principle of Bylaws

1) The Fort McMurray District Council Bylaws are approved in accordance with section 10 of the *District Councils Act*.

#### General

2) The President and Senior Executive Officer of the Otipemisiwak Métis Government are authorized and empowered to take all such further action and to execute and deliver all such further agreements, certificates, instruments, and documents, in the name and on behalf of the Otipemisiwak Métis Government and the Métis Nation of Alberta Association, to carry out the transactions contemplated by the intent and purposes of the foregoing resolutions.

#### WHEREAS:

A. Beginning in the 1950s and continuing until the 1990s, welfare agencies throughout Canada removed First Nations, Inuit, and Métis children from their parents, families, and communities and placed them with non-Indigenous foster or adoptive parents in a systemic practice known as the "Sixties Scoop".



B. The Sixties Scoop wrought enormous destruction upon First Nations, Inuit, and Métis communities—families were broken, children were disconnected from their cultures, and languages were lost. It is commonly accepted that these harms inflicted upon Indigenous individuals and collectives amounted to cultural genocide.

C. On June 21, 2018, the Crown reached a settlement agreement that resolved numerous class actions relating to the Sixties Scoop and resulted in compensation to all First Nations and Inuit victims of the Sixties Scoop between 1951 and 1991. The settlement agreement excluded Métis and non-status Indian victims of the Sixties Scoop.

D. On December 20, 2018, a class action was filed in the Federal Court seeking relief on behalf of individual Métis and non-status Indian victims of the Sixties Scoop that were excluded from the 2018 settlement agreement ("**Varley Action**").

E. The Otipemisiwak Métis Government and the Métis Nation of Alberta Association was granted leave to intervene in a summary judgment motion in the Varley Action heard December 9 to 12, 2024, in which, among other things, the plaintiffs sought declarations the federal Crown owed a duty of care and fiduciary duties to Métis and non-status Indian survivors of the Sixties Scoop.

F. On April 29, 2025, the Federal Court released its reasons for decision dismissing the majority of the plaintiffs' summary judgment motion. Among other things, the Federal Court declined to declare that the federal Crown owed a duty of care to class members—except in relation to Métis and non-status Indian Sixties Scoop survivors apprehended through the Saskatchewan "Adopt Indian Métis" program—and declined to declare that the federal Crown owed a fiduciary duty to class members.

G. On May 9, 2025, the Varley Action plaintiffs filed a Notice of Appeal with the Federal Court of Appeal, initiating an appeal of the Federal Court's decision dismissing the majority of the plaintiffs' summary judgement motion (**"Summary Judgment Appeal**").

H. The Otipemisiwak Métis Government is committed to holding the Crown accountable for all harms it has caused in relation to its abuses and negligence toward Métis children in care, their parents, their families, and their Métis communities, and—more generally—improving child and family services for the Métis Nation within Alberta on a culturally appropriate and respectful basis.

#### THEREFORE BE IT RESOLVED THAT:

1) Aird & Berlis LLP is directed to seek leave to intervene in the Summary Judgment Appeal on behalf of the Otipemisiwak Métis Government.



- If the Otipemisiwak Métis Government is granted leave to intervene in the Summary Judgment Appeal, Aird & Berlis LLP is directed to participate in the Summary Judgment Appeal on behalf of the Otipemisiwak Métis Government.
- 3) Administration is directed to develop and implement a communications strategy to ensure Citizens are informed, on an ongoing basis, about the Otipemisiwak Métis Government's participation in the Summary Judgment Appeal.
